

GENERAL GUIDELINES FOR ABSTRACT SUBMISSION FOR SCIENTIFIC PRESENTATIONS

Category of Paper / Poster:

Original Research / Rare Case Report or Case Series / Systematic Review / Narrative Review

1. The submitting author/Co-author should mandatorily registered for the conference.
2. The registered delegate will be allowed to present either a paper or poster.
3. For Poster presentation: up to two authors are allowed and certificate will be given to both the authors.
4. The submitting author must be listed as the first author
5. The author should present his/her original work.
6. The submitting author is required to ensure that all co-authors are aware of the content of the abstract before submission
7. The submitting student author should mandatorily take due signature from the Head of the Department
8. The abstract should be written in English.
9. Submitted abstracts should include non-published data and should not be previously presented at any other National or International forums.
10. The abstract that does not follow the guidelines will be asked to revise.
11. Abstract received after the given deadline will not be accepted.
12. The scientific committee will review all submitted abstracts. Notification regarding abstract acceptance and schedule of presentation will be sent to the submitting author.
13. The scientific committee reserves the right to change the category of the scientific presentation into either paper or poster depending on the availability of slots.
14. Specific guidelines regarding format of the paper/Poster presentation will be notified shortly.
15. Abstracts can be submitted for Paper or Poster under the category of Original Research/ Rare case Report or Case Series/ Review.
16. Title of abstract should be limited to 20 words for all categories.

17. Abstract for original research: Structured abstract under headings of Title, Objectives, Methods, Result, Conclusion and Key words. Maximum 250 words, excluding title and key words.
18. Abstract of Rare case report/Case Series: Title followed by unstructured abstract stating the significance and relevance of rarity of the presenting case. Maximum 150 words, excluding title and key words.
19. Abstract for Narrative Review: Title followed by unstructured abstract. Maximum 150 words, excluding title and key words.
20. Submitting author will receive correspondence about the abstract from the scientific committee.

E poster guide line:

Poster size and orientation

1. All posters will be set in landscape orientation (and all information (i.e. text, data, photos, and figures) must be designed to appear within one window/slide.
2. If you design your E-Poster in PowerPoint (PPT), ALL information must be appeared within ONE (1) slide only. Use Page Setup and choose Slide Size: "Custom 48" wide x 36" high (121.92 x 91.44 cm) with a **landscape** orientation.
3. Save your PPT into PDF format.
4. The resolution of the monitors used for e-poster presentation is 1920 x 1080 pixels and the size is "Custom 48" wide x 36" high (121.92 x 91.44 cm) with a **landscape** orientation.
5. All the presenters are required to set the resolution of their e-posters the same as the monitors'.

Essential Information to Include on E-Poster

1. Poster should be written ONLY in English language.
2. Poster Number (on the top left corner)
3. Title of the E-Poster (should be brief and match with the submitted abstract)

4. Names and affiliations of all authors (each author to be marked with superscript Arabic number (such as ¹, ²))
5. Arial font should be used throughout the poster with such clarity that it could be read from 1.5 meters distance. The title and subheadings should be written in bold. Italics should be avoided as it would be harder to read from a distance.
6. Please be considerate when using colors for the presentation, keep only 2-3 colors as this would be a formal scientific poster presentation. Please select background colors that contrast well with the font to allow easier reading of your text. Avoid background with bright or dark color and full of texture as this will distract readers.
7. Make sure that any photographs or figures being used in the poster are with sufficient size so that they are clearly visible, with a minimum 300-dpi resolution. The number of photographs should be limited to only those that are essential and relevant for the poster
8. Do not submit any photographs or pictures that are not relevant to the text, such as cartoon characters, etc. Photographs for case report presentation should be in standard quality for all extra-oral/intra-oral photos and pre-treatment/post-treatment photos. Radiographs view must be in good quality and have minimal distortion.
9. Graphs and tables should be well organized and the font used should be of a size that is easy to read.
10. Content of poster presentation
 - Research (Introduction, Objectives, Materials and Methods, Results, Conclusion, References and Acknowledgment).
 - Case Report (Introduction, Objectives, Case Operation Procedure, Discussion, Conclusion References and Acknowledgment).
 - Literature Review (Introduction, Literature studies, Discussion, Conclusion and References).
11. Declaration of Conflict of Interest for all authors; if there are no relevant conflicts, this must be included on the poster.
12. Data must be given in units that are generally accepted in scientific publications (international metric system is preferred)
13. At the footer/bottom part of poster presentation, should be noted : **Presented at 34th ISDR Conference**

21. The last date for abstract submission is 31st **December 2023**
